- ♦ LOAD THE RIGHT SIZE AMMUNITION AND ONLY WHEN READY TO FIRE
- ♦ THE SOUND OF A BELL, WHISTLE, OR RANGE SAFETY OFFICER CALLING CEASE FIRE MEANS STOP SHOOTING
 CEASE FIRE MEANS: STOP SHOOTING IMMEDIATELY, UNLOAD ALL AMMUNITION FROM FIREARM, AND OPEN CYLINDERS AND LOCK BACK SLIDES. REMOVE MAGAZINES AND LAY FIREARM ON TABLE. FIREARM MUST BE POINTED DOWN RANGE AT ALL TIMES!
- ♦ NEVER LAY A LOADED FIREARM DOWN. UNLOAD IT BEFORE LAYING IT DOWN
- ♦ UNCONTROLLED RAPID FIRE AND / OR FULLY AUTOMATIC FIRE ARE NOT PERMITTED
- ♦ IF A MALFUNCTION OCCURS, KEEP MUZZLE POINTED DOWN RANGE AND HOLD HAND UP TO NOTIFY RANGE SAFETY OFFICER IF IT CAN'T BE CLEARED
- ♦ BE CERTAIN THE RANGE SIDE DOOR IS CLOSED AND LOCKED AT ALL TIMES
- ◆ TABLES AND BENCHES SHOULD BE PUSHED UP AGAINST A WALL AT ALL TIMES. NEVER STAND IN FRONT OF A TABLE OR BENCH, ESPECIALLY IF FIREARMS ARE RESTING ON THE TABLE OR BENCH

General Range Safety Rules

- 1. Always keep firearms pointed in a safe direction down range.
- 2. **Always** keep your finger off the trigger until ready to shoot.
- 3. **Always** keep your gun unloaded until you are at the firing line and the range is declared "HOT." Firearms must be safe (unloaded magazines removed and actions opened) when not at the firing line.
- 4. **Cease Firing:** Immediately stop shooting when anyone calls "Cease firing."
- 5. **COLD Range:** Shooters must check with others to ensure firearms are unloaded, actions open and firearms laid down on the shooting bench before going down range. No one is permitted to handle any firearms or stand at the firing line while there is a cold range.
- 6. HOT Range: Shooters must check with others to ensure there is no one down range; when the range is declared "HOT" shooters are permitted to commence firing. Only shooters are permitted on the firing line. Shooters may move safe guns to and from the firing line only when the range is "HOT."
- 7. All shooters are responsible for their rounds staying within the confines of this range and not hitting the walls, ceiling, and floor. Shooters may shoot only from the firing line at the target in line with their position. Shooting at items placed on the ground or at targets not posted at the appropriate height enables rounds to escape the range or to hit the walls, ceiling, or floor.
- 8. **Respect the Range:** Please place your trash into the trash receptacles and your spent brass into the recycling receptacles. Tracer, armor piercing and incendiary ammunition is prohibited. When going downrange, do not walk in front of any firearms pointed downrange.
- 9. **Respect Yourself:** Wear eye and ear protection at all times on the Range. Food, beverages and smoking are not allowed on the Range. Wash your hands and face after shooting.
- 10. **Respect Others:** There is a two-hour time limit for use of the Range if other Members are waiting patiently.

THE RANGE AND ENTIRE DBPBA PROPERTY ARE MONITORED AND RECORDED BY HD 4K VIDEO CAMERA SURVEILLANCE AT ALL TIMES, DAY AND NIGHT, 24 / 7 – THE BOARD ACTIVELY MONITORS THE CAMERAS TO ENSURE COMPLIANCE WITH ALL RANGE RULES AND LAWS



MEMBERS SHALL IMMEDIATELY RECORD AND REPORT ANY AND ALL DAMAGE, RANGE RULE VIOLATIONS, NON-MEMBERS, AND/OR UNAUTHORIZED CALIBERS OBSERVED OR FOUND ON THE RANGE, ON THE RANGE SIGN-IN SHEETS AND IMMEDIATELY CALL A DBPBA BOARD MEMBER TO REPORT SUCH MATTER. THE BOARD WILL THEREAFTER REVIEW AND PRESERVE THE RECORDED VIDEO AS EVIDENCE FOR DISCIPLINARY ACTION.

DO NOT REPAIR, PAINT, OR PATCH THE RANGE WITHOUT PRIOR WRITTEN CONSENT AND APPROVAL BY THE BOARD, NO EXCEPTIONS.

I specifically acknowledge and understand that I am strictly prohibited to enter the Property (and range) when firearms are being discharged while under the influence of any alcohol and/or illegal drugs. I certify that I am not legally prohibited from possession firearms, nor is any action pending, which would restrict my right to possess or use firearms. I agree to immediately and at all times comply with all posted Range Rules and directions given by the DBPBA Board, Range Safety Officers and/or Safety Observers, and that I shall be responsible and liable for any damage caused by me to the range or its equipment. I enter into this agreement with the DBPBA with no reservations or purpose of evasion, and the agreement specified above will be binding upon me and my legal heirs, executors, successors and assigns. Notwithstanding anything to the contrary set forth herein, as consideration for my membership in the DBPBA, other rights, and access provided to me by the DBPBA and to the Property, I fully indemnify, hold harmless, and release the DBPBA and its Shareholders, Directors, Officers, Members, Agents and Representatives from and against any and all claims, damages, liabilities, expenses, and costs arising out of or related to my acts and/or omissions while I am on the DBPBA Property. I assume all risks of entering upon and/or using said Property and hereby waive and release the DBPBA from any and all claims, damages, liabilities, expenses, and costs arising out of or related to my access and / or use of said Property.
